SECOND AMENDMENT OF THE BY-LAWS OF SAN LUIS PASS RESORT COMMUNITY CIVIC ASSOCIATION

Let it be known that according to Article X. Amendments: The by-laws of this corporation may be amended, repealed, or added to, or new by-laws may be adopted by the vote or written assent of a majority of the members entitled to vote or by the vote of a majority of a quorum at a meeting duly called for the purpose according to the articles or by-laws. According to Article III, Section six of the by-laws the members holding ten percent (10%) of the votes that may be cast at any meeting shall constitute a quorum at such meeting. After notice to the members on June 12, 1999 a members meeting was held for the purpose of election and the amendment of the bylaws. The members voted by a majority vote of a quorum the following amendments of the bylaws:

RESOLVED THAT, the Bylaws be amended to reflect the following change:

ARTICLE IV Board of Directors

Section Two: NUMBER, TENURE, QUALIFICATIONS: The number of directors shall be seven (7). Each director shall hold office for two years until the term expires. Directors duly elected shall determine who shall hold the initial one year or two year term, thereafter at each election shall be elected for two year terms at the next annual meeting of members or until his successor shall have been elected and qualified. Directors must be full members of the corporation

Approved on the 12th day of June 1999.
